 - 1. Commission mtg update \$180,000 approved for Promo Fund, \$140,000 approved for purse fund, \$7,500 approved for 6 additional RV hookups.
 - 2. Legislative session update All bills concerning the racing commission, dog wagering and HHR have been voted down, altered, or withdrawn except for one. Bill SB2384 passed in the senate, and we are waiting for updates to provide testimony and reach out to representatives. Judiciary Committee.
 - 3. 2025 Race Dates and meet concerns July 12th 13th, 18th 19th, 25th 26th, August 2nd 3rd. Friday 5pm, Saturday/Sunday 12pm. Free T-Shirts, Horses and Heroes (cowboy hall of fame), dollar day, family day, ND Derby day, Casino night, Corgi Races, mystery voucher.

4. Video proposal – Site on Sound - \$72k initial quote (4k) Reduced to \$53k and they are willing to trade the labor to be the exclusive video partner. John Bubel made a motion to allow Pete to be a designated Agent with all the powers listed on the "Entity Authorization" form. Leigh
